Obici Healthcare Foundation Awards over \$1.3M in Grants to Nine Nonprofit Partners

(SUFFOLK, VA) Sept. 10, 2018 – The Obici Healthcare Foundation has awarded over \$46 million in grants since 2006. The fall 2018 grant awards total over \$1.3M and represent funding to 9 nonprofit partners serving Western Tidewater and Gates County, North Carolina. “Grants awarded in this funding cycle have a one-year timeline to ensure these partnerships continue as we transition to a new strategic grantmaking focus,” said CEO Annette Beuchler.

The Western Tidewater Free Clinic will receive a grant of \$595,000.00 in this grant cycle. The clinic offers care to the uninsured, regardless of the patient’s ability to pay and understands and addresses the challenges and opportunities of working with their patients. The funding will provide resources for staffing and additional pharmacy costs needed to serve an increased number of clinic patients. “We are proud to continue our partnership with the Western Tidewater Free Clinic as well as other nonprofit partners working to improve the health status of the area served by the Foundation,” stated Scott Carr, Obici Healthcare Foundation Chairman.
